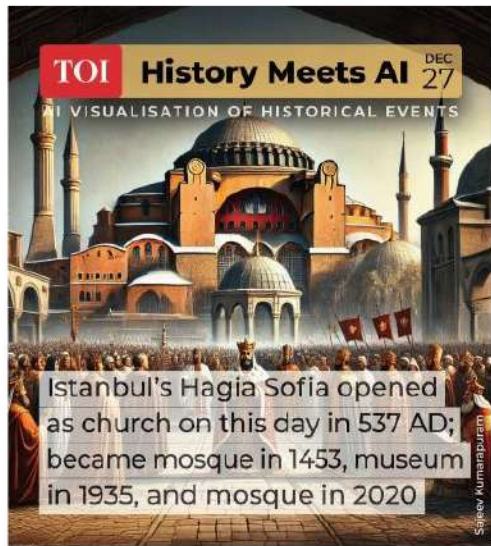

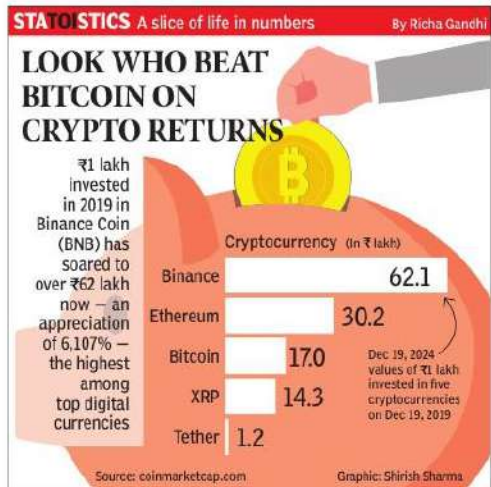

Raj tanker fire toll mounts to 19
The death toll in a tanker-fire incident in Rajasthan has gone up to 19 with another man succumbing to his severe burn injuries at the Sawai Man Singh hospital in Jaipur on Thursday. The hospital superintendent, Dr Sushil Bhati, said that one more death was recorded on Thursday, taking the total number of fatalities in the horrific incident to 19. "Currently, 11 people are undergoing treatment at the hospital," he said, adding that two or three of them are likely to be discharged on Thursday. Lalaram (28), who died on Thursday, had 60% burn injuries and was on a ventilator. Three more patients are on ventilator support. The body has been shifted to the hospital's mortuary for postmortem. Lalaram's friend Ramavtar said he was a security guard in an IT company at the Mahindra SEZ. He was on his way to work when he got trapped in the fire. "He was on a motorcycle when the incident happened," Ramavtar said. Three people, who sustained injuries in the incident, died on Wednesday. **TNN**



Tusker visits Dudhia picnic spot, guided back to forest in 6-hr op

Siliguri: A solitary tusker visited a popular picnic destination merely 26km from Siliguri on Thursday, causing alarm. The elephant was spotted in Dudhia, on the road connecting the spot to Siliguri. After a six-hour-long operation, forest officials guided the elephant back to the forest and confirmed that there were no injuries or damage to properties. The elephant, said foresters, had strayed from Lohagarh forest of Kurseong forest division's Panighata range and travelled through tea gardens to reach Dudhia. "We managed to guide the elephant through Longview tea garden, across the Balasambal bridge, and eventually into Bamanpokhari forest area after six long hours. The elephant had entered Dudhia around 7.30am and we were able to drive it to the forest by 1.30pm. Patrolling is on to monitor the area", said Panighata forest range officer Samiran Raj. Kurseong DFO Devesh Pandey said: "We appeal to people go for picnics only in designated areas. We urge them not to film or take photos or try to get close to an animal."

'Minor acts': School brushed aside teen's bid to strangle 2 kids

What made police change track in the Hathras school murder case after the five arrested persons had allegedly "confessed"? Hathras ASP Ashok Kumar, who led the probe, told TOI. "It was based on preliminary evidence collected at the crime scene that we arrested the five individuals." At first glance, the case was indeed clear-cut. The accused had, after all, travelled long distances with the dead child's body in the boot of his car.

The yarn, though, began to fray under closer scrutiny. Kumar said, "Our investigation was still on and weeks of interviews with other teachers, students and domestic staff uncovered inconsistencies that challenged the narrative. Through these follow-ups, new evidence emerged that led us to the teenager. Upon questioning, he confessed to strangling Kritarth Kushwaha to death."

The boy was quietly taken into custody on Dec 16 and sent to a juvenile home. The 13-year-old's confession was a troubling revelation for the police. In July he had attempted to strangle two other students but the school brushed aside these incidents as "minor acts of misbehaviour". On the night of Sept 22, his obsession took a more solid, darker shape. Kritarth was found lifeless in his dormitory bed the next morning.

The school's manager, Dinesh Baghel, along with his father, Jashodan Singh, and a teacher, placed the boy's body in the boot of their car and drove from Hathras to Agra through Aligarh, hoping that distance would dissolve the magnitude of the crime. By the time police caught up with them, the narrative of a "child sacrifice" had taken root and cemented their roles in the killing.

Lost 49 years ago, UP woman returns to kin

Azamgarh: Phoolmati, 57, and her brother Laldhar, two years her elder, hugged for the first time in 49 years on Thursday. It was a poignant moment that had improbably written all over it since the day an eight-year-old girl in pigtails who still couldn't pronounce her father's name became a memory frozen in time — as much in her own mind as her family's.

All that Phoolmati could recollect since her life took a fateful turn in 1975 were two names and a landmark — Chituidand, her native village in UP; Ramchander, her maternal uncle; and a well in the courtyard of her grandparents' house.

A man dressed as a sadhu had convinced her to accompany him to a village fair, but took her to Moradabad instead, where she was "sold" to a much older groom. She became a mother to a son some years after the underage marriage, lost her husband not much later, and slipped into a life of struggle and drudgery that would have remained so but for an extraordinary twist that every lost-and-found story needs.

As Phoolmati's journey climaxed in a family reunion in Vedpur village of UP's Azamgarh, she poured her gratitude on the school headmistress who kicked-started the search for her antecedents and the police team that made it possible.

Phoolmati, who cooks midday meals in a primary school at Pajawa in Rampur district's Bilaspur, had confided in Dr Pooja Rani about her early life. When the teacher Googled "Chituidand", she learnt that the village in Mau district was previously part of Azamgarh district. She immediately contacted Azamgarh Police and passed on the other details.

"We are always eager to trace and reunite missing people with their families. But Phoolmati's case was challenging as she had very little information from her childhood," Azamgarh SP Hemraj

Meena said. "But ASP (city) Shailendra Lal wanted to give it a shot and his team worked hard on this."

Azamgarh's Latghat outpost in-charge Zafar Khan was the first to reach Chituidand, which is under the jurisdiction of Doharighat police station, after confirming that a man named Ramchander used to live there, and that there was a well outside the house.

While Ramchander and another maternal uncle of Phoolmati died years ago, their youngest brother Ramhit, 85, still lives there with his family. Ramhit led police to Vedpur village in Raunagar. It was there that Phoolmati's late father, Vikram, had set up home.

A police team visited Phoolmati and her factory worker son Sompal in Rampur and ferried them to Vedpur. "I was only 10 when she vanished. After looking for her for a few months, our family gave my sister up for dead," Laldhar said.

The siblings' father died a couple of years later, while their mother, Shyamadevi, passed away in 2000. "My parents told me I had a younger sister who got lost and never returned. I wish they were alive today to see her," Laldhar said.
