'Michael' gets \$21 million in California tax credits

Los Angeles, Mar 8: Michael Jackson's biopic 'Michael', will receive more than \$21 million in California tax credits, the state's film commission announced recently. The California Film Commission announced the latest round of credit allocations, totalling \$81.7 million for 24 projects, reports 'Variety'. The commission stated that 'Michael' will generate \$120 million in "qualified" in-state spending, which is more than any other project in the 14-year history of the tax credit programme.

The project was announced in January, with Jackson's nephew Jaafar in the lead role. John Branca and John McClain, the executors of the Jackson estate, are producing with Graham King. As per 'Variety', the project comes with controversy. Dan Reed, the director of 'Leaving Neverland', the documentary that accused Jackson of sexually assaulting two young boys, slammed the new film in a Guardian column, saying it will "will glorify a man who raped children."

The state film commission also announced that 'The Thomas Crown Affair' will receive \$13.8 million, and an untitled Disney live-action film will be awarded \$11.3 million.

Europe to start charging for entry in 2024

The long-anticipated ETIAS visa waiver scheme, which will require all non-EU passport holders to get pre-trip permission to enter the bloc, was supposed to launch by November this year. But it has been pushed back to 2024.



It'll be a fast online authorization for non-EU nationals from the 60 or so countries that don't currently need a visa to the EU – such as the United States and the United Kingdom – and will work a lot like the United States' ESTA program. It'll cost 7 euro (\$7.43 on Friday afternoon's exchange rates) and will cover you for three years. However, compared to the ESTA – \$21 for two years – that's admittedly kind of a bargain.

Forest fires pose threat to Wayanad tourism

Wayanad, Mar 8: Amid increasing forest fires amid soaring temperatures Wayanad Prakruthi Samrakshana Samithi (WPSS) has written to the Head of Forest Force Bennichen Thomas to close down tourism activities across the three forest divisions in the district.



In his letter, WPSS president N. Badusha termed protected areas in Wayanad "a ticking time bomb" that called for immediate attention in view of localised forest fires that have been reported recently in the neighbouring protected areas including Bandipur, Nagarhole and Mudumalai tiger reserve. Besides, there have been reports of forest fires within the Wayanad wildlife sanctuary and Chembra hills. Moreover, elephants are known to migrate towards Wayanad during such dry months. Under such circumstances, he said, forest fires are likely to aggravate human-animal conflicts in the region. Mr. Badusha added the management plan of the Wayanad Wildlife Sanctuary mandated the suspension of all tourism activities from February 15 to April 30. "This is a critical precautionary measure that

needs to be followed without fail. However, four years ago, when the Forest department failed to stop such activities, we were forced to witness the entire Chembra grasslands in the South Wayanad division burn into ashes," he cautioned.

American Airlines bans Indian student for misbehaviour

Chennai, Mar 8: American Airlines has banned the Indian passenger, who had allegedly urinated on a fellow passenger while being drunk on a New York-New Delhi flight. The accused, identified as 21-year-old Arya Vohra, a student at a US university, has been banned by the airline.

The airline said in a statement that it will not allow the passenger on board in the future. The statement further said that the American Airlines flight AA292 from John F Kennedy International Airport to Indira Gandhi International Airport was met by local law enforcement upon arrival due to a disruptive customer. The flight landed safely at 9.50 p.m. on Saturday. "Upon aircraft arrival, the purser informed that the passenger was heavily intoxicated, and was not adhering to crew instructions on board. He was repeatedly arguing with the operating crew, was not willing to be seated and continuously endangering the safety of the crew and aircraft. "After disturbing the safety of fellow passengers, finally urinated on a passenger seated on seat 15G," the airline said.
