## जमतारा मॉड्यूलचा सायबर दहशतवाद!

तुमच्या मोबाईलवर अचानक एक व्हिडीओ कॉल येतो. कॉल करणारा म्हणतो - "तुमच्यावर अटक वॉरंट आहे... तुम्ही इग्न तस्करीत गुंतलेले आहात आता डिनोटल अरेस्ट होणार!" आणि क्षणात तुमचं आयुष्य हादरून जातं कारण हे कुणी पोलिस नव्हे, तर 'जमतारा मॉड्यूल'मधील सायबर दरोडेखोर असतात!

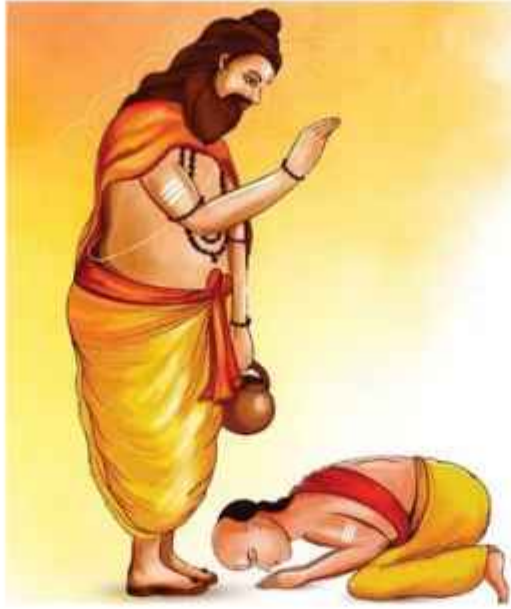
हे केवळ फसवणूक नसून सायबर युद्ध आहे, जे शिक्षित नागरिकांपासून निवृत्त अधिकाऱ्यांपर्यंत सगळ्यांना मिळकत करत आहे. जगात आतापर्यंत दोन महायुद्धे झाली आहेत. जग तिसऱ्या महायुद्धाच्या उंबरठ्यावर उभे आहे. यामध्ये सायबर यंत्रणेची बऱ्यापैकी साथ असल्याचे सध्या रशिया-युक्रेन, इराण-इस्रायल आणि भारताने दहशतवाद्यांविरुद्ध राबविलेल्या ऑपरेशन सिंदूर दरम्यान जगाने पाहिले आहे. मात्र हे सायबरचे यंत्र समानकेंद्रकांच्या हातात पडले असून, खुलेआम त्यांनी नागरिकांना 'सडको की पडो' करून सोडले आहे. यामुळे देशात सुरु झालेल्या सायबर दरोडेखोरांच्या जमतारा मॉड्यूलच्या मुसक्या लवकरात लवकर आवळणे आवश्यक आहे.

देशात सायबर फसवणूक म्हटली की 'जमतारा' हे नाव डोक्यासमोर येते. झारखंडमधील जमतारा जिद्दातील बहुतांश मंडळी सायबर फसवणूकीत सक्रिय आहेत. 'जमतारा' नावाने एक वेबसिरीज आल्यानंतर हे मॉड्यूल समोर आले. जमतारा जिद्दात सर्वाधिक सायबर धांमटे असून ते देशभरात विविध सायबर युद्धात सक्रिय आहेत. तर काही सायबर धांमटे हे देशातील विविध राण्यात सक्रीय आहेत. दिल्लीतील नोएडा सेक्टर तर गुन्हेगारांचा अड्डा बनला आहे. बोगस कॉल सेंटरपासून ते सायबर ठगी अशी चुना लावणारी दुकानदारी येथून सुरु आहे. या सर्वांचे बऱ्यापैकी कनेक्शन हे छत्तीसगढ राण्यातील जमतारा येथे आहे. यामुळे सायबर दरोडेखोरांच्या जमतारा मॉड्यूलचा लवकरच पर्दाफाश करणे आवश्यक आहे. तरच देशातील नागरिक खऱ्या अर्थाने सुटकेचा श्वास घेईल.

जमतारा मॉड्यूलच्या सायबर जाळ्यात अनेकजणांनी आपल्या आयुष्याची पुंजी पणाला लावली आहे. तर फसवणूकीची रक्कम ही देशातील विविध बँकांमध्ये जमा केली जात असल्याचे आढळून आले आहे. त्यातच छत्तीसगढमधील बस्तर जिद्दात फसवणूकीचा एक गुन्हा दाखल होता. या गुन्हातील रक्कम मुंबईतील बँक खात्यात वळती करण्यात आली होती. ती रक्कम काढण्यासाठी सायबर धांमटे मुंबईत आल्याची माहिती कांदिवली पोलिसांच्या सायबर कक्षाला मिळाली होती. त्यानुसार सायबर कक्षाने कांदिवली येथील एका हॉटेलामध्ये छाप टाकून तीन सायबर धांमटांचा अटक केली. त्यांच्याकडून बँकांची ५६ एटीएम कार्डे, आठ मोबाईल आणि १० हजार रुपये जप्त करण्यात आले. सायबर गुन्हेगार वेगवेगळ्या प्रकारे फसवणूक करीत आहेत. फसवणूकीतून आलेले पैसे थेट आपल्या खात्याऐवजी दुसऱ्या बँक खात्यात वळते करतात. त्याला 'थर्ड पार्टी अकाऊंट' असे म्हटले जाते. काही व्यक्तींना कमिशन देण्याचे आमिष दाखवून त्यांची बँक खाती उघडली जातात, तर अनेकांच्या आधार कार्डांचे तपशील मिळवून त्या आधार अशी बँक खाती उघडण्यात येतात. त्या बँक खात्यात ही रक्कम जमा करण्यात येते. फसवणूकीचे पैसे अशा खात्यात आले की सायबर धांमटे ती रक्कम काढतात. ला

आपल्या मोबाईलवर व्हिडीओ कॉल येतो तेव्हा कॉल करणाऱ्या सायबर धांमटाच्या पाठीमागे पोलीस किंवा सीबीआय कार्यालय असल्याचे फोटो दिसतात. फोन करणारा धांमटा बऱ्याचदा खाकी वर्दीत असतो. आपल्याविरुद्ध अटकेचे वॉरंट आहे. आपण गुन्हेगार आहात. आपणास डिजिटल अटक करण्यात आली आहे. तुम्ही इग्नच्या तस्करीत गुंतलेले आहात किंवा आपल्या आधारकार्डाचा गैरवापर झाला आहे. आता आपली या प्रकरणातून सुटका नाही. आपल्याविरुद्धची कारवाई जर थांबवायची असेल तर आम्ही सांगतो त्याप्रमाणे करा! आम्ही दिलेल्या बँक खात्यात पैसे जमा करा. आरटीओएस करा. असे न केल्यास तुम्हाला परिणाम भोगावे लागतील. सायबर धांमटांच्या या व अशा धमक्यांनंतर बहुसंख्य स्त्रो-पुरुष धांमटांमध्ये घरातील कुणाला न सांगता आपल्या बँक खात्यातील पैसे सायबर माफियांनी नमूद केलेल्या बँक खात्यात ट्रान्सफर करतात. वारंवारच्या धमक्यांना धाबवरून आपल्या बँक एफडी मोडतात. घरात असलेले सारे दागिनेही विकतात. बँक खात्यात, घरात काहीच शिल्लक राहत नाही तेव्हा फसलेले स्त्रो-पुरुष पोलिसांकडे धाव घेतात. तेव्हा वेळ निघून गेलेली असते.

हे केवळ देशातील सायबर धांमटे किंवा जमतारा मॉड्यूल करीत नाही. तर देशातील ज्येष्ठ नागरिकांना देशोधडीला लावणारे सायबर माफिया परदेशी देखील आहेत. सायबर माफियांनी चीन, म्यानमार, कंबोडिया, दुबई, स्विट्झर्लंडमधील दावोस आदी देशांत कॉल सेंटर्स उभारली आहेत. त्यात बहुसंख्य भारतीय तरुणांची भरती करण्यात आलेली आहे. नोकरी शोधत असलेल्या भारतीय तरुणांची दिशाभूल करून त्यांना कॉल सेंटर्समध्ये बसविले जाते. हीच तरुण पोरं भारतीयांना फोन करतात आणि करोडो रुपयांना गंडा घालतात. हा गुन्हा आहे. आपली फसवणूक झाली आहे असे लक्षात आल्यावर भारतीय तरुण मुलं पुन्हा भारतात परतण्याचा प्रयत्न करतात. तेव्हा परदेशी सायबर माफिया त्या तरुणांचे पासपोर्ट काढून घेतात. कॉल सेंटर्समध्ये काम करण्यासाठी त्यांच्यावर नबरदस्ती करतात. अलीकडेच म्यानमारमधील कॉल सेंटर्समध्ये अडकलेल्या ६०० भारतीय तरुणांची मुंबई क्राईम बँचच्या अधिकाऱ्यांनी सुटका केली. त्यात महाराष्ट्रातील ३० तरुणांचा समावेश होता. याप्रकरणी वर्तमानपत्रातील फसवण्या जाहिराती पाहून तरुणांना परदेशात नोकरी मिळवून देणाऱ्या दोन एजंटनाही अटक करण्यात आली होती. तेव्हा नोकरीच्या शोधात असलेल्या तरुणांना सावधान.
