Shinde announces special Assembly session for Maratha quota in Feb

Session will be held after a review of the report from the state backward class commission

MAHARASHTRA CHIEF Minister Eknath Shinde on Tuesday announced that a special session of the state legislature will be held in February 2024 after a review of the report from the state backward class commission to extend reservation to Maratha community.

"We have reconstituted the state backward class commission with a financial provision of Rs 360 crore. The commission has been asked to give a report on empirical data to prove social and educational backwardness of Marathas. Based on this report, reservation for the Maratha

community will be finalised. We have asked the commission to give its report in one month," said Shinde in the legislative assembly. He was replying to a discussion on Maratha reservation. "After we take the report

from the commission, a special session of the state legislature will be held in February 2024 to give reservation to Marathas," Shinde said.

"We need to prove exceptional and extraordinary circumstances whereby social and educational backwardness of Marathas will be decided," he said.

The Opposition slammed the state government for not mentioning the issue of caste census. "The only way to give reservation to Marathas is to have caste census, but nowhere did the Chief Minister mention this. There was no clarity on how Rs 360 crore will be spent. The government should answer," said Congress MLA and Maharashtra Congress

Chief Nana Patole.

Shinde's announcement comes days before the deadline of December 24 set by Maratha activist Manoj Jarange-Patil seeking Kunbi (OBC) certificate for Marathas. During his speech, Shinde said several times that the reservation for Marathas will not impact that of any other community.

Justice (Retired) Sandeep Shinde committee appointed by the state government to finalise the procedure to give Kunbi certificate to Marathas submitted its second report of 403- pages to Shinde on Monday. "It will be given to the Law and Judiciary department now and after legal scrutiny, it will be placed before the state cabinet," he said.

Shinde stressed that evidence from before 1967 will be considered when giving Kunbi certificate, which will also extend to certificate holders' blood relatives. "I will take the oath of Chhatrapati Shivaji Maharaj to give reservation to Marathas. I will take oath for any community which needs help, not only for Marathas," said Shinde. He added that any individual who tries to get a fake caste certificate will be dealt with seriously.

The CM added that the present pending curative petition in the Supreme Court too would be dealt with by the legal team of the state government where additional statistical data and information will be shared within the Supreme Court.

PLOT TO BOMB AMERICAN SCHOOL

HC refuses bail, suspension of life-term of man held in 2014

THE BOMBAY High Court recently rejected a petition filed by Anees Shalal Ahmed Ansari, who was arrested in 2014 for an alleged conspiracy to attack the American School in Mumbai, seeking suspension of sentence and release on bail pending his appeal. The HC said it was disinclined to grant relief to Ansari in the light of the evidence against him and expedited hearing in his criminal appeal.

The sessions court on October 21 last year had convicted and sentenced Ansari to life imprisonment for offences punishable under Section 66F of Information Technology Act, 2000 and five-year imprisonment for offences under IPC.

As per Maharashtra Anti-Terrorism Squad (ATS), during the period between August 2011 and October 2014, Ansari created an account on Facebook using a fake identity. The ATS claimed that he 'misused' computer devices of the IT company he was working with for these activities. The ATS claimed that between October 13 and 18, 2014, Ansari used the computer

devices to 'spread terror activities' propagated by Islamic State. As per prosecution, the agency received intelligence that Ansari was a 'jihadist' and conspired to attack foreign officials in Mumbai and American School.

Senior advocate Mihir Desai for Ansari claimed before a division bench that he has been in custody for over nine years, therefore, he should be released on bail pending the hearing. Desai also argued that Ansari was erroneously convicted for the offence punishable under Section 66F of IT Act.

He also claimed that there was no evidence to substantiate the 'cyber terrorism' charge against Ansari.

Additional Public Prosecutor M M Deshmukh, representing ATS, opposed the plea and argued that the offence against Ansari was of serious nature and there was enough evidence to establish the charges against him. Deshmukh argued that prosecution has examined nearly 25 witnesses to prove its case and their evidence, along with the Facebook chats, showed Ansari's involvement in the crime and therefore he should not be granted any relief.

"In the light of the nature of evidence against the applicant, we are not inclined to suspend the sentence of imprisonment and grant bail to the applicant," the HC said.

Temperatures set to drop in Mumbai after Christmas: IMD

AFTER RECORDING temperatures below 20 degree Celsius in the past week, the minimum temperatures in Mumbai have clocked a significant spike of 3-4 degrees since Monday. According to the India Meteorological Department (IMD), the city is slated to experience a fall in temperature after December 25.

On Tuesday, minimum temperatures at IMD's Santacruz recording station touched 23.7 degrees, a departure of six degrees above normal while at the Colaba observatory, minimum

temperatures soared close to 25 degrees at 24.4 degrees Celsius.

On Monday, the minimum temperatures in Santacruz touched 23.6 degrees while the Colaba coastal station registered 24 degree Celsius, reflecting a stark spike from last week during which the city recorded its lowest temperature of the season at 19.4 degrees.

Sunil Kamble, director of IMD Mumbai, told *The Indian Express*. "After December 25, we are expecting a decrease in the temperature owing to the western disturbances as well as northerlies. However, until then the minimum temperatures will fall between the range of 21-22 degrees."

On the rise in mercury levels, Kamble said, "As per a weather system, there is a cyclonic circulation in the Arabian Sea. While it is far from the city, it is resulting in a rise in the temperature."

Meanwhile, Mahesh Palawat, from Skymet Weather Services, attributed the escalation in temperatures to the presence of a trough over North Konkan. "Whenever there is a trough, there is an anti-clockwise wind movement. The inland winds from the south east are coming in and therefore, there has been a rise. The temperature levels will remain higher until the northerlies set in," Palawat told *The Indian Express*.

Sought talks on security breach, but govt running away: Sule

Mumbai: Sharad Pawar-led NCP faction working president Supriya Sule was among the MPs suspended from Lok Sabha on Tuesday for demanding a reply from Prime Minister Narendra Modi and Union Home Minister Amit Shah on the recent security breach in Parliament. With this, the total number of Opposition MPs suspended during the Winter Session has reached 141.

Responding to the develop-

ments, Supriya Sule said, "We were just asking for a reply (from the government on the Parliament security breach incident) and a discussion in the House. This is an important issue but the government is running away from a discussion on it."

A senior BJP functionary said, "The suspension in Lok Sabha is not against any individual or party. The Speaker has taken a decision in accordance with the rules laid down." ENS
