Powerful quake kills 1,000...

were felt some 375 kilometers away in the Pakistani capital of Islamabad.

Footage from Paktika showed men carrying people in blankets to waiting helicopters. Others were treated on the ground.

One resident could be seen receiving IV fluids while sitting in a plastic chair outside the rubble of his home and still more were sprawled on gurneys.

Some images showed residents picking through clay bricks and other rubble from destroyed stone houses, some of whose roofs or walls had caved in.

The death toll given by the Bakhtar News Agency was equal to that of a quake in 2002 in northern

Afghanistan. Those are the deadliest since 1998, when a 6.1 magnitude tremor and subsequent tremors in Afghanistan's remote northeast killed at least 4,500 people. In most places in the world, an earthquake of that magnitude wouldn't inflict such extensive devastation, said Robert Sanders, a seismologist with the US Geological Survey.

But a quake's death toll more often comes down to geography, building quality and population density.

"Because of the mountainous area, there are rockslides and landslides that we won't know about until later reporting. Older buildings are likely to crumble and fail," he said.

Eknath Shinde claims support of 46 MLAs

Aghadi (MVA) Government to the brink, party MP Sanjay Raut on said the ongoing political developments in Maharashtra could lead to dissolution of the State Assembly.

The Sena strongman Eknath Shinde, a Cabinet Minister, said the MVA, formed in November 2019, was beneficial only to alliance partners the Congress and the NCP, while ordinary Shiv Sainiks have suffered the most in the last two-and-a-half years of the coalition's existence.

"It is necessary to quit the unnatural alliance for the sake of Shiv Sainiks and the Shiv Sena. It is important to take a decision in the interest of the state," Shinde, who is camping in Guwahati along with rebel Sena MLAs, tweeted.

His tweets were in Marathi with #Hindutvaforever.

Shinde maintained that while the NCP and the Congress were growing stronger in the MVA alliance, the Shiv Sena, which heads the governing bloc, and its workers were getting systematically weakened.

Shinde, who has appointed his own chief whip of the Sena legislature, said he has 46 MLAs supporting him. "I have more numbers (of Shiv Sena MLAs) than needed (to form a separate group in the Assembly without inviting the anti-defection law provisions)," he told a Marathi TV channel. The Sena has 55 members in the 288-member Maharashtra Assembly.

A chartered flight carrying Shinde and Shiv Sena MLAs, who have rebelled against the party and were camping in a luxury hotel in Surat after raising a banner of revolt on Monday night, reached Guwahati in the BJP-ruled Assam in the early hours of Wednesday.

The banks also issued a Look Out Circular against Kapil and Dheeraj Wadhawan on October 18, 2019 to prevent them from leaving the country, they said.

The UBI has alleged that KPMG, in its audit, red-flagged diversion of funds in the garb of loans and advances to related and interconnected entities and individuals of DHFL and its directors.

The scrutiny of account books showed that 66 entities having commonalities with DHFL promoters were disbursed Rs 29,100 crore

against which Rs 29,849 crore remained outstanding.

"Most of the transactions of such entities and individuals were in the nature of investments in land and properties," the bank alleged.

It revealed that the DHFL, in number of instances, disbursed funds within one of month, diverted funds for investment in entities of Shetty, loans were rolled over without NPA classification, repayments worth hundreds of crores was untraceable in bank statements and unjustified moratorium on principal and interest was given.

Expecting 7.5 pc economic growth rate this year: PM

NEW DELHI, June 22 (PTI)

THE Government expects the Indian economy to grow by 7.5 per cent this year, Prime Minister Narendra Modi said on Wednesday. In a virtual address at the BRICS Business Forum, Modi also said the value of the Indian digital economy will reach USD 1 trillion by 2025.

Highlighting the strength of the Indian economy, he said there is an opportunity to invest USD 1.5 trillion under the country's national infrastructure pipeline. "We are expecting a 7.5-per cent growth rate this year that will make us the fastest growing major econo-



my," Modi said in his address.

In a "New India", transformative changes are taking place in every sector, he said, adding that a key pillar of the country's economic recovery is technology-led growth.

"We are supporting innovation in every sector," the Prime Minister said. The BRICS

Parab reached the ED office around 3.45 pm for his ques-

tioning in the money laundering probe linked to the alleged violation of coastal regulation zone provisions in the construction of Sai resort in Dapoli beach area of Maharashtra's Ratnagiri district, an official said.

Parab, who was questioned by the central agency for more than 10 hours on Tuesday, was summoned on Wednesday morning as well.

Marathi actor Ketaki Chitale gets bail

THANE, June 22 (PTI)

MORE than a month after she was arrested for allegedly sharing an objectionable post about NCP chief Sharad Pawar on social media, a court in Thane district of Maharashtra on Wednesday granted bail to Marathi actor Ketaki Chitale in connection with the case.

District judge H M Patwardhan granted bail to her on a surety of Rs 20,000. With this, Chitale will be able to walk out of the Thane central jail. On May 14, 2022, Thane police had arrested Chitale for sharing on Facebook a Marathi verse, which allegedly referred to NCP chief Sharad Pawar in a derogatory way.

5 cops, home guard stabbed inside police station in Delhi

NEW DELHI, June 22 (PTI)

FIVE policemen and a home guard were stabbed by a man inside a police station in east Delhi's Shahdara on Wednesday, officials said.

The incident took place on the third floor of cyber police station, Shahdara, they said.

The man is being questioned, police said. According to police, the man entered the police station and started recording a video. When he was obstructed by one of the policemen and asked the reason behind recording the video, the man suddenly took out a knife and stabbed the personnel one after the other. All the injured policemen and the home guard were rushed to hospital where they are being treated. One of the cops sustained injuries on his chest and is critical, they said.

Meanwhile, the man later claimed that he was a complainant, but no complaint copy was found with him.

Police said he also banged his head against the wall and sustained minor injuries.

"As per preliminary enquiry, only one person is suspected to be involved in the incident," a senior officer said.
