Maharashtra State Road Transport Corporation (MSRTC) passengers will soon be able to book their tickets through the Indian Railway Catering and Tourism Corporation (IRCTC) portal. The latter signed a Memorandum of Understanding (MoU) with the state transport firm on Wednesday.

As per IRCTC officials, the MoU outlines a comprehensive scope of work and the facility is expected to be operational by the end of this month. Detailed roles and responsibilities of both IRCTC and MSRTC will be finalised to execute this project effectively, the official said.

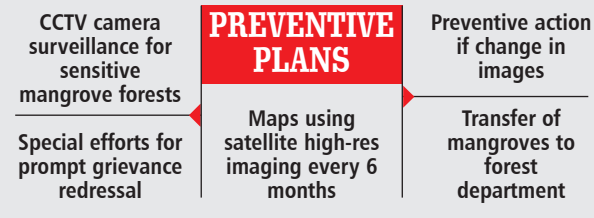
IRCTC CMD Seema Kumar said she is enthusiastic about this integration with seamless access to last-mile connectivity. Another senior official said that MSRTC will provide the application programming interface of its online ticketing system to IRCTC for integration into the latter's website and mobile apps at <https://www.buses.irctc.co.in>.

Since its inception in 1999, IRCTC has continually evolved as a one-stop travelling solution in India, officials said. They added that over 75% of railway passengers already book rail journey tickets through this online portal.

Mangroves to be under watchful eye of CCTVs

Mangrove Protection & Conservation Committee says it's committed to prompt grievance redressal; environmentalists express grave doubts

CCTV cameras will soon be installed to monitor the disturbance in sensitive mangrove forest areas. The decision was taken at a Mangrove Forest Protection and Conservation Committee meeting at Konkan Bhavan on Tuesday.

Konkan Divisional Commissioner Dr Mahendra Kalyankar instructed all government agencies to coordinate their efforts and sought special efforts for prompt grievance redressal. It was decided that maps of the mangrove forest area in Maharashtra will be prepared every six months using satellite high-resolution images. Preventive measures will be taken if any changes are found in these images. Transferring the areas to the forest department was also discussed.

However, environmentalists have expressed doubts. BN Kumar from NatConnect Foundation said, "This is the

nth time that the High Court appointed mangrove protection and conservation committee has discussed transferring mangroves to the forest department." He added that the court's five-year-old order for the handover is being openly flouted and there

has been no action whatsoever against the erring government agencies, except for issuing directives and deadlines.

The latest deadline that was given to CIDCO was one month; nearly 1,200-hectare of mangroves were to be

handed over by October 30, as per information given by the state mangrove cell in response to NatConnect's complaint to the Prime Minister. "The Chief Minister passes our complaints to the environment and forest departments for action and inaction is there for all of us to see," he said.

"The mangrove committee is our last hope to save the tidal plants and it must act strictly now," Kumar said and recalled the reminders that sound like tareeq pe tareeq (date on date).

The meeting was attended by Additional Principal Conservator of Forests (Kandavan) SV Ram Rao through video conference. The participants included Member Secretary and Deputy Conservator of Forests (Mangroves) Anita Patil, Deputy Superintendent of Police (Home) Sanjay Sawant, Assistant Commissioner of Police Jitendra Javale and Deputy Regional Officer of Maharashtra Pollution Control Board Rupali Sonkamble.

After opening one arm of Delisle road overbridge (ROB) connecting GK Marg with NM Joshi Marg, the BMC will now open the left portion of the second arm connecting Lower Parel with Currey Road on September 18. Sources said the BMC plans to open the entire bridge by the end of November.

As a mark of token agitation against missing several deadlines in the last five years, the Lower Parel Nagrik Uddhanpul Kruti Samiti took children on a picnic to the bridge site. The citizens' body is demanding that the entire bridge be thrown open or they will stage a huge agitation.

The ROB is a crucial link between Lower Parel, Worli, Prabhadevi and Currey Road in the west and Byculla and other areas in the east. It was shut on July 24, 2018, after being declared unsafe by the Indian Institute of Technology Bombay. Its closure has inconvenienced local residents and office-goers as traffic has been affected in the Parel, Dadar TT and Mahalaxmi areas for the last five years.

1st e-bus batch on Mira-Bhayandar roads by Ganeshotsav

The first batch of electric buses will be inducted into the existing fleet of the public transport authority attached to the Mira Bhayandar Municipal Corporation (MBMC) on Ganesh Utsav.

The MBMC has placed an order of 57 e-buses. While 32 (midi buses) out of the 57 electric buses will be 9-meter-long and without air-conditioners, 15 will be regular non-AC buses and remaining 10 will be air-conditioned buses. The 12

and 9-metre buses will have a seating capacity of 39 and 31 plus drivers, respectively. "We will shortly get the delivery of five midi buses which will start plying during Ganesh Utsav. Routes are be-

ing planned accordingly. We are expecting to get the remaining midi buses next month," confirmed additional municipal commissioner Aniket Manorkar. The e-bus project is being

implemented under the aegis of the National Clean Air Programme (NCAP) mooted by the Central government for improving air quality. Newly appointed civic chief Sanjay Katkar had recently inspected a demo bus to evaluate the performance of the vehicle.

At present, 71 out of the 74 diesel-powered buses operate on 18 routes which have an average ridership of 90,000 commuters per day as collections hover above Rs.8 lakh. The addition will take the existing fleet size to 131 buses.
