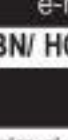
**PGET-2023 - ADMISSION TO POST GRADUATE MEDICAL AND DENTAL COURSES
 FOR THE YEAR 2023-24 IN THE STATE OF KARNATAKA AND
 ADMISSION TO IN-SERVICE SEATS OF DNB (PRIMARY AND SECONDARY) AND DIPLOMA (NBEMS)**

- 1) In pursuant to the directions from the Government in its letter MED 66 RGU 2023, Bangalore dated: 12-06-2023, KEA is inviting applications online for admissions to PG Medical and Dental courses from the eligible candidates who have qualified in NEET-PG-2023 / NEET MDS - 2023 for the year 2023-24 for the available PG Medical and Dental Degree / Diploma courses in Government Medical / Dental colleges, Government Quota seats in Private and Minority Medical and Dental Colleges and Private seats in Private Medical and Dental colleges (KPCF, KRLMPCA, AMPCK and Private Universities) located in the State of Karnataka for the academic year 2023-24.
- 2) As per Government Order No. HFW 882 HSH 2021 Bangalore Dated: 10-01-2022, KEA is also inviting application online from the eligible Karnataka in-service candidates who have qualified in NEET-PG-2023 and desirous of applying DNB / Diploma Courses in the State of Karnataka for the academic year 2023-24.
- 3) The candidates who have scored more than or equal to the prescribed minimum score in NEET PG 2023 / NEET MDS-2023 only are eligible to register and apply online for PG Medical and Dental courses for the year 2023-24.
- 4) Non-Karnataka candidates will not be eligible for reservation. Hence, in the NEET-PG 2023 / NEET MDS - 2023 examination, if they have scored the required minimum 50th percentile or above, fixed for 'GENERAL (UR)' category as per the qualifying criteria, then only they are eligible to register for admissions through KEA or for any other seats in the State of Karnataka. Please note that SC/ST/OBC eligibility criteria are applicable to Karnataka SC / ST / OBC candidates only.
- 5) Interested and eligible candidates can register and apply online for PGET-2023 **from 26-07-2023 (11.00 am onwards) up to 30-07-2023 - 11.59 pm**. Fee has to be paid by the registered and applied candidate **on or before 31-07-2023 - 6.00 pm**.
- 6) Registration fee, schedule for verification of documents, original documents to be produced for verification and other details will be hosted on the KEA Website. Interested eligible candidates can register and apply online and appear for document verification as per the schedule.
- 7) Information Bulletin-2023 detailing admission eligibility criteria and other details are hosted on the KEA Website: <http://kea.kar.nic.in> for the information of the candidates. Before registering through online for admission to PG Medical and PG Dental courses in the state of Karnataka, applicants are hereby informed to read the Information Bulletin PGNEET-2023 and understand the eligibility conditions, educational qualification, classification of seats (different types of category of seats) and eligibility to claim such seats.
- 8) Mere qualifying in NEET-PG 2023 / NEET MDS-2023 does not confer any right on the candidate for admission unless the candidate fulfils eligibility conditions / submits the documents / certificates. Further, only the candidates who complete the registration process including document verification are eligible for PG Medical / Dental seats in Government / Private Colleges in Karnataka.
