Treta ke Thakur temple is located at the Naya Ghat Ayodhya. It is a popular temple on the banks of Saraya Ghat. The temple is dedicated to Lord Ram, who is referred to as the Lord of Treta Yug. The temple was built at the place where Ram conducted the ‘Ashwadmedha Yagna’ to celebrate the victory over Ravana.

History
The temple was built

by the King of Kulu 300 years ago. The temple was renovated in 1784 AD by Maratha Queen Ahalyabai Holkar.

Architecture
The temple is an excellent piece of north Indian Nagar-style Hindu temple architecture that has conventional shikaras. The idols in the temple are black and made of a single black stone.

Legend
The temple was the

venue where Lord Ram performed the Ashwamedha Yajna (the horse sacrifice) and set up images for himself and Devi Sita. Those images are said to have been thrown into the river by the Mughal emperor Aurangzeb. The horse sacrifice is the best sacrifice a king can perform. Only kings who aspire to universal dominion can perform the yajna.

Prior to the sacrifice, the horse with the auspicious mark is let loose to wander at will anywhere for a year. An army follows the horse, and anyone who tries to stop the horse is considered an enemy, and his act is a challenge to the owner of the horse. He has to be vanquished. After a year, the horse comes back, and the sacrifice and feasting take place. The Lord performed

the yajna, and no one stopped the horse except Lav and Kush, sons of Rama. They were twins born to Sita Devi while she stayed in the ashram of Sage Valmiki when she was abandoned by Ram. Both Luv and Kush, being sons of Ram, wanted to know many things about their mother’s stay in the ashram. Since Ram was not accompanying the horse, they stopped the horse to force Ram to come to them. They refused to release the horse when many pleaded with them. They released the horse only when their doubts were cleared by Ram. Then only, the sacrifice went on smoothly as per ritual.

Deities
The temple houses the idols of Lord Ram, goddess Sita, Lakshmanan, Bharathan, Shatrughnan, Hanuman and Sage Vashishtha. These idols are black and made of single black sandstone.

Darshan and festival
The temple is open to the devotees only once a year on Karthik Shukla Ekadashi, which falls in the month of October/ November. Devotees who come and pray to Lord Ram here get their wishes fulfilled. The temple remains open for 24 hours on this day.

Ayodhya Tretanath Temple

Built by Kulu King 300 years ago



Treta ke Thakur temple is located at the Naya Ghat Ayodhya. It is a popular temple on the banks of Saraya Ghat. The temple is dedicated to Lord Ram, who is referred to as the Lord of Treta Yuga. The temple was built at the place where Ram conducted the 'Ashwamedha Yagna' to celebrate the victory over Ravana.

History

The temple was built by the King of Kulu 300 years ago. The temple was renovated in 1784 AD by Maratha Queen Ahalyabai Holkar.

Architecture

The temple is an excellent piece of north Indian Nagar-style Hindu temple architecture that has conventional shikaras. The idols in the temple are black and made of a single black stone.

Legend
The temple was the venue where Lord Ram performed the Ashwamedha Yajna (the horse sacrifice) and set up images for himself and Devi Sita. Those images are said to have been thrown into the river by the Mughal emperor Aurangzeb. The horse sacrifice is the best sacrifice a king can perform. Only kings who aspire to universal dominion can perform the yajna.

Prior to the sacrifice, the horse with the auspicious mark is let loose to wander at will anywhere for a year. An army follows the horse, and anyone who tries to stop the horse is considered an enemy, and his act is a challenge to the owner of the horse. He has to be vanquished. After a year, the horse comes back, and the sacrifice and feasting take place.

The Lord performed the yajna, and no one stopped the horse except Lav and Kush, sons of Rama. They were twins born to Sita Devi while she stayed in the ashram of Sage Valmiki when she was abandoned by Ram. Both Luv and Kush, being sons of Ram, wanted to know many things about their mother's stay in the ashram. Since Ram was not accompanying the horse, they stopped the horse to force Ram to come to them. They refused to release the horse when many pleaded with them. They released the horse only when their doubts were cleared by Ram. Then only, the sacrifice went on smoothly as per ritual.

Deities

The temple houses the idols of Lord Ram, goddess Sita, Lakshmanan, Bharathan, Shatrughnan, Hanuman and Sage Vashishtha. These idols are black and made of single black sandstone.

Darshan and festival

The temple is open to the devotees only once a year on Karthik Shukla Ekadashi, which falls in the month of October/November. Devotees who come and pray to Lord Ram here get their wishes fulfilled. The temple remains open for 24 hours on this day.
