Diversion of Funds
Potential round tripping of Funds through Lcs: 31 instances totaling to Rs 143.31 Cr where money was received back from the Lcs beneficiary in company's bank books within 10 days of opening of LC. This indicates potential round tripping of funds and appears mere book entries without any actual purchase/sale of goods. Out of 31 instances, 11 transactions amounting to Rs 41.04 Cr were with entities related to STML through directors/ executives or common directors.

Thus the Bank's funds have been diverted by the borrower in collusion with guarantor Sh. Sanjay Gupta & Ajay Gupta.

Siphoning of Funds:

1. Invoice issued by LC beneficiaries recorded at incorrect value in the purchase register
In special investigation, it was found that in case of 10 invoices raised by the LC beneficiaries provided to the consortium Banks, it was found that invoice value recorded in the purchase registers of the company was lower than the value mentioned on the invoices, aggregating to roughly Rs 0.41 Cr. This indicates inflated invoice value and manipulation of the financial statement of the company. Thus the Bank's funds have been siphoned off.

2. Same invoice submitted to two different banks at the time of LC discounting:
The borrower availed non-fund based credit from two different banks on the same invoice amounting to Rs 0.17 Cr. This indicated possible double borrowing for procurement of same goods. Similarly in 7 instances the borrower was found to have submitted the same export order for availing export packing credit (EPC) to two different banks.
