As per the regulation 16A of Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, The voting share of a creditor in a class shall be in proportion to the financial debt which includes interest at the rate of 8 % p.a (eight percent per annum) unless a different rate has been agreed to between the par
3. The claims admitted are subject to further substantiation / modification on the basis of additional evidence or clarifications.
- 4.Claim pertaining to previous land owners arising out of Development Agreement are considered as NIL in terms of value but the same has been considered as home buyer claim as the liability of CD to provide them Flats in the property is arising out of settlement with the previous land owners.
5. Claim of homebuyers who have bought flats /residential untis from Previous Land Owner are rejected in towards payment made for Stamp Duty , Registration Charges as well as all indirect Taxes but their claim as Allotees are accepted.
6. As per the information provided by Secured Financial Creditor - LICHFLAMC, the CD had sold the flats to the Homebuers wihtout obtaining NOC from them.
