The claim of Tata Capital Financial Services Ltd. has been admitted as a Financial Creditor, in view of an Order passed by this Hon'ble NCLT, Hyderabad Bench dated July 06, 2020 (received on July 08, 2020) in IA No. 994/2019 in CP (IB) No. 276/7/HDB/2018. An appeal against the said Order has been preferred before Appellate Tribunal, which is pending adjudication. The treatment of the claim and that of lease rentals during CIRP period as CIRP Cost, is without prejudice and shall be subject to outcome of the said Appeal.

These Operational Creditors have not submitted the proof of claims in the prescribed form, till date. Therefore, no amount is admissible.

Notes	
1	The interest amount is admitted, as per the terms mentioned /agreed in the invoice or other equivalent document.
2	The retention amount, wherever applicable is included in the admissible amount.
3	As per Regulation 12(2) of CIRP Regulations A creditor, who fails to submit claim with proof within the time stipulated in the public announcement, may submit the claim with proof to the interim resolution professional or the resolution professional, as the case may be, on or before the ninetieth (90) day of the insolvency commencement date. Accordingly claims received upto November 27, 2018 have been verified and admitted. However, the Hon'ble NCLT, Principal Bench, New Delhi in CA No. 1082(PB)/2019 and CA No. 1084 (PB)/2019 in CP (IB) No. 1083(PB)/2018, vide its order dated June 06, 2019 in the matter of Adel Landmarks Limited held that provision of regulation 12(2) is directory and thus, rejection of claim on ground of delay is not sustainable. Accordingly the claims received after Ninetieth day ie November 27, 2018 are being verified and may be admitted upon due verification. Claims tabulated under sr. no. 113 to 123 are received after ninetieth (90) day.
4	The Hon'ble NCLT vide its order in IA No. 1085/2019 in CP (IB) No. 276/7/HDB/2018 dated June 09, 2020 had directed Power Grid Corporation of India Limited ("Applicant/PGLIL") to approach Resolution Professional ("RP") by filing its revised claim Form before the RP for consideration and verification. Accordingly, on receipt of the revised claim from PGLIL, after verification of all the relevant documents, the claim amounting to Rs. 19,28,00,000/- towards relinquishment charges has been admitted in addition to the claim for sum of Rs. 201,25,89,789/- which was already admitted.
5	The claim of Tata Capital Financial Services Ltd. has been admitted as a Financial Creditor, in view of an Order passed by this Hon'ble NCLT, Hyderabad Bench dated July 06, 2020 (received on July 08, 2020) in IA No. 994/2019 in CP (IB) No. 276/7/HDB/2018. An appeal against the said Order has been preferred before Appellate Tribunal, which is pending adjudication. The treatment of the claim and that of lease rentals during CIRP period as CIRP Cost, is without prejudice and shall be subject to outcome of the said Appeal.
6	On July 17, 2020, the Resolution Professional received a claim in Form B dated July 17, 2020 from the GST Department for an amount of Rs. 17,85,92,917/-. The RP has preferred an application seeking appropriate orders in respect of the Claim Form received by the GST Department, post approval of the Resolution Plan by CoC and the same being reserved for Orders by the Hon'ble Tribunal.
