Notes:

1 Where a Homebuyer is member of Ekta Consumer Association and has claimed interest at 24%, we have admitted the same only if the same interest rate is mentinoed in the Agreement of Sale or MoU between the parties, otherwise claims are admitted at 8% interest.

2 Claims of Homebuyers mentioned in Sr. No. 8 & 53 are not in the reckoning since their claims are against one of the group companies of Corporate Debtor and not the Corporate Debtor. Other claims from Homebuyers which are not admitted are due to insufficient data to recommend for admission. Further information has been called for.

3 Where the rate of interest entitled is not specified in his claim form / supporting documents, 8% interest is considered as per regulation 16A(7) of IBBI(Insolvency Resolution Process for Corporate persons) Regulation, 2016.

4 Where the rate of interest is wrongly claimed by the HomeBuyers, then the rate mentioned in the Allotment Letter/Agreement of Sale/ MoU between the HomeBuyer and Corporate Debtor is considered for admission.

5 Where the rate of interest is wrongly claimed by the HomeBuyers and the the Allotment Letter/Agreement of Sale/ MoU is silent on the rate, then 8% interest is considered as per regulation 16A(7) of IBBI(Insolvency Resolution Process for Corproate persons) Regulation, 2016 in admission of claim.

6 We have not considered any damages/deposits claimed by Homebuyers while admitting the claims.

7 Wherever refund has been indicated by the claimant, it is adjusted. We have no method of ascertaining whether any refund has been made to the Claimants / others.

8 Limitation issue has not been addressed since payments have been made to the Corporate Debtor over a period of time, some parties have received refund and many cases have been instituted in city Civil Court, national Consumer Forum and Criminal Complaints for dishonoring of Cheque. As these details is not available determining the limitation issue is a challenge.

9 Homebuyers Sunaina Anil Mirachandani & Anil Chetan Mirchandani's claim has now been verified & admitted vide NCLT order dated 20.10.2021 in IA 1993/2021.
