**Assured Return-** The assured return has admitted and accepted for 3 years period @ Rs. 80/- per square feet to the allottees who have produced the MOU/ Agreement to Sale/ other relevant documents in support of the assured return offered by the corporate debtor. The said amount of the admitted assured return has been set off by the amount if any received by the allotees.

**NAM (Not Appropriately Mentioned)-** Certain Space Buyers have filled forms inadequately by keeping the claim amount blank or specified that they want their space, Interest, Penalty, Refund etc. in the claim amount column. In such cases, we have looked at the attached supporting documents and verified the claims and admitted the claims.
