However in term of the Extension of Mortgage documents created by the Corporate debtor on 01.03.2017, guarantee being restricted to the value of Kumardhubi Unit I or Rs.61.89 Crores, total admissible claims for the respective lender being part of the Consortium was considered proportionate to their claims admitted vis-a-vis maximum value of the Kumardhubi Unit I taken at Rs.61.89 Crores. - Claims for the Corporate Guarantee given by the CD against financial assistance to its Parent Company being Mcnally Bharat Engineering Co. Ltd are further liable to be readjusted or redistributed on receipt of any further claims from the lenders being part of the Consortium and has not filed their claim as on the date of Constitution of CoC & thereafter within the timeline as provided under Regulation 12(2) of IBB(CIRP) Regulation 2016.
