### Note on Security Interest

2

Banks from Sr. No. 1 to Sr. No. 1 to Sr. No. 8 are part of a consortium headed by Union Bank of India as the Lead Banker (hereinafter referred as 'UBI Consortium'). The Principal Inter Se Agreement is dated 25th July, 2011 and the latest Inter Se Agreement is the 4th Supplemental Inter Se Agreement dated 17th March, 2020.

UBI Consortium has First Pari Passu charge by way of Mortgage on Immovable Properties owned by Corporate Debtor itself and its Promoter / Promoter Group Entities. The Security interest for all the Bank is covered in the UBI Consortium. IRP has not received the requisite data from any of the Claimant to verify the security interest as a whole for UBI Consortium. Multiple Claim forms either doesnt mention their amount of loan covered under security interest or have not provided with the requisite documents to substantiate their amount of security interest and thus IRP at this moment is unable to determine the amount covered by Security Interest or Guarantee due to lack of data from the Claimants.

IRP has sought for requisite information from the Claimants with regards to the Charge on Security Interest other than the assets owned by Corporate Debtor and also to substantiate the amount of Security Interest. The said information is pending to be received from the Claimants and subject to changes, if any, upon receipt and verification of the same.

IRP is made available with the bank statements of the members of Consortium. Pending clarifications/ working on the claim amount from some of the members of the consortium, IRP has considered the statements as on the relevant dates as mentioned in the below table:
