The claim filed by the AR for the above 39 employees is INR 85,58,807 of which the amount already held by LIC Trust towards Gratuity is INR 57,00,139. The net amount of claim is INR 38,59,668. As per Section 4(f) of the Payment of Gratuity Act, 1972, a person is eligible for gratuity on termination of his employment after he has rendered continuous service for not less than 5 years. Claims of such employees have been rejected who have either not completed 5 years of uninterrupted service or are currently on the payroll of the Company. The claim amount which has not been admitted for such employees is INR 35,78,807.
