1.EMPLOYESS STATE INSURANCE CORPORATION-CLAIM: The ESIC has made a claim for the contributions and interest till October,2022 whereas there were no employees from January 2021. Therefore the contribution,interest and damages will be reduced substantially. The R.P has requested for a revised claim.

3.EMPLOYEES PROVIDENT FUND ORGANIZATION- CLAIM: The claim from Provident Fund is Rs.181,02,204/- is received and admitted based on Form B received from the department. Later a revised claim is received on 21.04.2023 from PF department for Rs.1,74,41,040/-. The amount mentioned in the order dated 21.04.2023 towards contribution is Rs.79,53,708/-(order states excluding interest and damages) whereas Form B submitted indicates Contribution as Rs.7953708/ & Interest w/s 7Q as Rs.3056356/- and Damages w/s 14Q as Rs.6367062/-. There is a short remittance of Rs.62814 and Administrative charges at Rs.1100/- Thereby totalling Rs.17441040/- as claim. However, the P.F.portal indicates Rs.873661/ towards Damages and Interest payable. Therefore, interest payable and damages is under verification. A petition to waive the damages and interest will be submitted. Therefore, the dues payable may vary in the future.
