

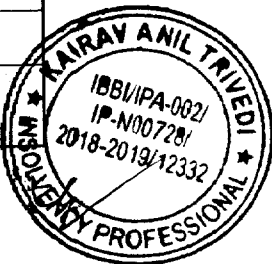

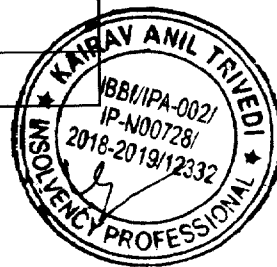

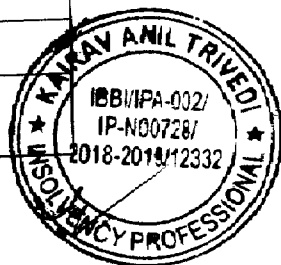

1. All the above claims received from employees need to be verified with the records of the company, being updated and in the process of audit,
2. the claims received from Directors of the company are shown as claims not admitted,
3. the claims for which physical copy not received are kept as under verification.
