- 1 As per preliminary information, 6 Flats bearing Flat No. 304, 404, 504, 604, 704 and 804, 2 Shops bearing No.1 and 9 on Ground Floor and 2 Offices bearing No.1 and 2 on the First Floor in the Building "Vijay Galaxy" constructed by the Corporate Debtor has been sold by the Corporate Debtor to Mr. Rajan Chhibber and Ms. Payal Parekh, prior to commencement of the Corporate Insolvency Resolution Process of the Corporate Debtor and that in pursuance thereto the Corporate Debtor has already handed over the possession of the aforesaid 10 premises in the Building "Vijay Galaxy" to Mr. Rajan Chhibber and Ms. Payal Parekh., hence claim is not admitted.
- 2 Home Buyer's claim for Stamp Duty and registration fees have not been admitted, as the payments for stamp duty and registration charges was not made to corporate Debtor. Based on various documents produced amount of stamp duty is Rs. 2,45,50,980 and registration fees is Rs. 17,40,000.
