#### Note on updated claim submitted by UBI- SARB on 24-1-2025.

- 1. The Union Bank of India—Special Assets Recovery Branch, Visakhapatnam, has submitted a revised claim in Form C. The reason for the submission of the revised claim is that one of the collateral securities held by the bank, which pertains to the corporate debtor, was sold under the SARFAESI Act for ₹8.39 crores before the commencement of CIRP. A sale certificate confirming the sale of the asset to the auction purchaser was issued on 30th May 2024.
- 2. Subsequently, the promoters of the corporate debtor challenged the financial creditor's actions under the SARFAESI Act by filing SA 243/2023 before the Hon'ble Debt Recovery Tribunal (DRT), Visakhapatnam. On 1st June 2024, the DRT passed an order staying further actions concerning the said security until 13th June 2024. On 14th June 2024, the DRT issued another order, stating: Further proceedings for the scheduled property, which has been auctioned/sold and for which the sale certificate was issued prior to the Hon'ble NCLT order dated 10th June 2024, are stayed. Accordingly, the DRT allowed IA 1310/2024, directed the respondent bank to file a reply with all relevant documents, and fixed the next hearing for SA 243/2023 on 25th July 2024. Due to this order, the registration of the said security in the name of the auction purchaser is still pending.
- 3. The auction purchaser subsequently approached the Hon'ble High Court of Andhra Pradesh by filing WP No. 18322/2024. On 22nd August 2024, the Hon'ble High Court passed an interim order stating that the operation of the DRT order dated 14th June 2024 in IA No. 1310/2024 in SA 243/2023 shall remain stayed.
- 4. The matter was listed again on 7th January 2025 and adjourned to 18th February 2025. In its order dated 7th January 2025, the Hon'ble High Court directed that the interim order granted earlier in WP No. 18322/2024 would continue to operate until the next date of hearing.
- 5. In view of the above circumstances, and considering the ongoing litigation before the Hon'ble High Court of Andhra Pradesh regarding the property sold by the Union Bank of India under the SARFAESI Act, the bank has adjusted the sale proceeds from the earlier claim submitted on 25th June 2024. Consequently, it has submitted a revised claim dated 24th January 2025.

## Note on the Claim Submitted by Central Power Distribution Corporation of Andhra Pradesh Limited.

#### 1. Initial Submission and Clarification.

The Central Power Distribution Corporation of Andhra Pradesh Limited (APCPDCL) initially submitted its claim on 11th April 2025. Upon review, the Resolution Professional (RP) sought several clarifications regarding the claim amount. Subsequently, APCPDCL submitted the revised claim along with all necessary clarifications and supporting documents on 5th May 2025.
