Note :

1) Some employee claims were received after the regulated timeline. So, as per the amended Regulation 12 & 13 issued by Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) dated 18th September 2023, these claims were placed before the CoC for their recommendation in the 16th CoC meeting held on 15/05/2025. The same was approved by the CoC through e-voting for being included in the list of Creditors. The Resolution Professional is in the process of filing application before the Hon'ble NCLT for condonation of delay of these claims.
