- The above claims of employees have been provisionally admitted based on the details / information provided by SBoD. The claims are subject to change / modification when any further information is made available.
- There are two employees of Solapur whose claims have not been received, however, they have been provisionally admitted based on their communication and the employee outstanding details provided by SBoD namely J. S. Ghanate for Rs 15,983 and Mahadev Datta Gawalim for Rs.12,729.
- For Claims pertaining to Solapur employees (1 - 126) - The list of employees and their outstanding as per the books are provided by the SBoD which mentions name of approx. 300 employees. However the above claims pertain to the employees who have either filed claim through email or have tried to submit their details on email to RP. There are certain claims wherein the name of employee were not exact match with records provided by SBOD. Further clarification to the same have been sought from SBoD to verify the claims and revert is awaited. The claims have been thus provisionally admitted based on our best judgment, and are subject to change / revision / modification when any fresh / new / revised information is received. Certain claims of employees are under verification as liabilities are not reported/ confirmed from the details provided by SBoD. The initial response to the claims have been shared with the claimants and their claims may be considered after receiving confirmation and additional details.
- Regarding Sadashivpet Ex-employee/ Ex- workmen Claims KOBO - On 19.03.2025 Mr A Pradeep Kumar, stating himself to be General Secretary and authorised representative (AR) of 96 workmen previously employed at Plant of Corporate Debtor located at Sadasivpet , emailed claim Form E (Proof of Claim by AR) and RP replied informing that the claim is received beyond the last date of submission of claim and after the issuance of RFRP and reason for delay was sought. Since the matter pertained to dues to workmen / employees, RP accorded it priority and sought information / confirmation from SBoD (Suspended Board of Directors). After persistent follow up, on 1.4.2025 SBoD informed that certain dues are pending to be paid to ex-workmen / ex-employees previously employed at Sadasivpet Plant on account of Voluntary Separation scheme. On 2.4.2025 it was further informed that total amount pending is Rs 210 lakhs, which comprises Rs 2,18,750/- payable to each of 96 ex-workmen/ ex-employees and the list of these persons was provided in the copy of the settlement agreement. The AR has filed IA with NCLT for condoning the delay in IA (IBC) 853/2025 and as per the Hon'ble NCLT Order dated 02.06.2025, the delay was condoned. Based on the data provided by SBoD and the provision made in the Books of Account, thus claims of 96 ex-workers/ex-employees are being admitted for Rs. 2,18,750/- each thus a total claim of Rs. 210 lakhs is being admitted against the he total claimed amount of Rs. 5,79,58,272/- . Claim pertaining to Sr. No. 127 to 222 mentioned above in claim list is of Sadashivpet Ex- Employees /Ex -Workmen whose names have been taken from the Settlement Agreement dated 17.04.2025 provided by the SBoD and the settlement agreement shall override the above claims.
