Note 1: Pursuant to the Public Announcement, the Applicant received 168 claims from creditors in a class (Financial Creditors) up to the last date for submission of claims, i.e., 06.05.2026. Subsequently, during the course of verification, additional claims were received up to 12.05.2026, which were included in the list of creditors annexed to the Application filed on 13.05.2026, bearing IA No. 2277/2026. Accordingly, the total number of claims received from financial creditors in a class as on 12.05.2026 stood at 179. Further, additional documents and information pertaining to existing claims, along with certain fresh claims from financial creditors in a class, were received up to 24.06.2026, increasing the total number of Financial Creditors in a class to 197. However, 7 out of the aforesaid 197 Financial Creditors in a class failed to furnish complete information and supporting documents required for verification of their claims and communication for rejection of their claim has been communicated to them. Accordingly, such creditors have been excluded from the re-constituted list of Financial Creditors in a class as on 24.06.2026.
