1. As per Regulation 14 of IBC 2016-

Where the amount claimed by a creditor is not precise due to any contingency or other reason, the interim resolution professional or the resolution professional, as the case may be, shall make the best estimate of the amount of the claim based on the information available with him. The interim resolution professional or the resolution professional, as the case may be, shall revise the amounts of claims admitted, including the estimates of claims made under sub regulation (1), as soon as may be practicable, when he comes across additional information warranting such revision.

2. The claims if not submitted in appropriate claim form have been provisionally admitted at notional amount of Rs. 1.

3. Claims have been provisionally admitted by IRP on the basis of records / documents submitted by the creditors, as the updated books of accounts available with IRP.

4. The claims where admitted are subject to further revision/substantiation/modification on the basis of any additional information / evidence / clarification which may be received subsequently and which warrant such revision/substantiation/modification.

5. Information / evidence / clarification may also be pending from Operational Creditor/Management/Employees for the claims under further verification.

6. It is noted that certain claimants have submitted their claim in the alternative — seeking either execution/registration of the Sale Deed for their unit, or, alternatively, refund of the amount paid by them. As regards the request for registry/handover of possession, the same shall be placed before the Committee of Creditors at its first meeting for approval under Regulation 4E of the IBBI (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, which requires approval by not less than sixty-six percent (66%) of the total voting share of the Committee of Creditors before the Resolution Professional may hand over possession of the plot/apartment/building and facilitate its registration, subject to the allottee having performed his/her part under the agreement (i.e., paid all dues). The Interim Resolution Professional/Resolution Professional shall proceed strictly in accordance with the decision of the Committee of Creditors in this regard. Where a claimant has, in the alternative, sought refund instead of registry, that claim shall continue to be processed as an ordinary monetary claim under Regulation 13, and shall not fall within the scope of Regulation 4E. 7. Several claimants holds possession of the unit and a registered Sale Deed, and has filed a claim for the cost of completing the balance/pending works in the project. The claims for pending or incomplete construction work is admitted at a notional value of ₹1. In the absence of an independent technical evaluation, no monetary estimation is made at this stage. The cost to complete the real estate project will be professionally assessed by appointing an independent Registered Valuer.

8. The amount of this claim has been provisionally admitted and is subject to revision, both upward and downward, upon receipt of further information/documents from the claimant, and upon completion of verification under Regulation 13 of the IBBI (Insolvency Resolution Process for Corporate Persons) Regulations, 2016. The Resolution Professional has considered claims received up to 07.08.2026, being the last date for submission of claims as per the Public Announcement; any claim or document received thereafter shall be dealt with separately in accordance with the Code and the Regulations

9. Claims filed by the claimants have been admitted to the extent of the amount so claimed. Where the claimant has requested for registration of sale deed and not furnished/claimed of principle and interest at the rate of 8% per annum, the amount corresponding to such interest and principle has not been admitted. Upon receipt of the requisite documents/revised claim form from the claimant, the claim shall be reviewed and the admitted amount updated accordingly.
