Vinayak Nagar, Kismidesar, Bikaner admeasuring 3516.63 sq. mtrs owned by Shri Arvind Singh Chauhan.** Note ** Property situated at Bikanerwas put for auctionunder SARFAESI Act with a reserve price of Rs. 360 Lacs, auction was scheduled on 29.06.2026. Borrower approached DRT-Jaipur against the auction process and submitted inclination to redeem the property for Rs.360 Lacs. Hon’ble DRT-Jaipur passed the order to release the property by accepting Rs. 360 Lacs vide order dated 19.06.2026 out of which Rs.90 lacs to be deposited on or before 29.06.2026(date of auction) and remaining Rs.270 lacs within 2 months i.e on or before 29.08.2026. The property belongs to personal guarantors against whom we have filed application u/s. 95 of IBC post amendment in IBC. Therefore moratorium does not applies. Hence the same propertyis out of the purview of the CIRP proceedings and once borrower deposited the full amount property will be released to comply with the direction of DRT order dated 19.06.2026 (copy of the order is Annexed as per list). On the last date of hearing 05.08.2026 counsel of the guarantor categorically prayed to release the property once they deposit the amount as per DRT order dt. 19.06.2026. The Hon’ble PO DRT-Jaipur reiterated the order dated 19.06.2026 to release the property in compliance of the order.
