**ORDER**

This Company Petition is filed by Konkan Minerals Private Limited., under Section 10 of Insolvency and Bankruptcy Code 2016 ("the Code") read with Rule 7 of Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules 2016 for initiation of Corporate Insolvency Resolution process.

2. The Corporate Debtor says that its registered office is at Plot No.118A, Bethora Industrial Estate, Ponda, Goa 403409, incorporated on 18.10.2004 vide CIN U27101GA2004PTC003640 on the file of Registrar of Companies Goa, Daman & Diu having Authorised share capital of Rs.1 crore and paid up share capital of Rs.1 crore.

3. The Board of Directors of the Corporate Debtor in their meeting held on 26.3.2017 authorised Mr. Prasada R. G. Rao, Director of the Company, to



file necessary application under the Code. The Corporate Debtor has proposed Mr. Velamur Varadan Anand, B 2101, Great Eastern Gardens, LBS Marg, Kanjur Marg (West), Mumbai - 400 078 Email ID: [velamur.anand@yahoo.co.in](mailto:velamur.anand@yahoo.co.in), Registration No. IBBI/IPA-002/IP-N00069/2017-18/10147, as interim resolution professional, who has given his consent with a declaration that no disciplinary proceedings are pending against him.

4. The Corporate Debtor has disclosed that a sum of Rs.323.85 Lakhs is in default to Financial Creditors and a sum of Rs.98.33 Lakhs is in default to Operational Creditors.

5. The Corporate Debtor enclosed the following with the application:

- a) Sanction Letter dated 11.1.2011 issued by Union Bank of India, Ponda, Goa, sanctioning Rs.1,00,00,000/- as Cash Credit and Rs.50,00,000 as Letter of Guarantee Facility and Rs.80,00,000 as Letter of Credit.
- b) Renewal letter dated 14.11.2014 issued by Union Bank of India, Ponda, Goa, sanctioning Rs.2,00,00,000/- as Cash Credit, Rs.50,00,000 as Adhoc Cash Credit, Rs.50,00,000 as Letter of Guarantee and Rs.1,40,00,000 as Letter of Credit.
- c) Copy of Certificate of Registration of Charge dated 14.11.2014, for creation of equitable mortgage.
- d) Notice dated 7.4.2016 under Section 13(2) of SARFASI Act, 2002 issued by Union Bank of India, Credit Recovery and legal Services Department, Panjim, Goa requiring the Corporate Debtor to pay a sum of Rs.3,23,84,890.07 as on 31.03.2016.



6. The above documents clearly reveal that the Corporate debtor borrowed money from bank and also defaulted in making payments to the Financial Creditor.

7. The Corporate Debtor has enclosed the audited financial statements for the year ended 31.03.2016 and 31.03.2017 and the provisional financial statement for the period up to 06.07.2017. A list of assets and liabilities of the Corporate Debtor as on 06.07.2017 and details of claim and its amount against properties mortgaged by the Corporate Debtor is also enclosed with the application. The Corporate Debtor also enclosed the list of financial creditors and operational creditors as on 06.07.2017. The Corporate Debtor has disclosed the particulars of debts owed by or to the Corporate Debtor to or by persons connected with it. The details of corporate and personal guarantees given in relation to the debts of the Corporate Debtor, the name and address of the members with details of respective shareholdings, and an affidavit in support of the petition were also enclosed with the petition.

8. On reading the petition and the supporting documents annexed with the petition, this Bench is of the view that the corporate debtor has committed default and the petition contains the particulars as required u/s 10 of the Code. Hence, this Bench hereby admits this petition, declaring moratorium with consequential directions as mentioned below:

(i) That this Bench hereby prohibits the institution of suits or continuation of pending suits or proceedings against the corporate debtor including execution of any judgment, decree or order in any court of law, tribunal, arbitration panel or other authority; transferring, encumbering, alienating or disposing of by the corporate debtor any of its assets or any legal right or beneficial interest therein; any action to foreclose, recover or enforce any security interest created by the corporate debtor in respect of its property including any action under the Securitisation and Reconstruction of



Financial Assets and Enforcement of Security Interest Act, 2002; the recovery of any property by an owner or lessor where such property is occupied by or in the possession of the corporate debtor.

(ii) That the supply of essential goods or services to the corporate debtor, if continuing, shall not be terminated or suspended or interrupted during moratorium period.

(iii) That the provisions of sub-section (1) of Section 14 shall not apply to such transactions as may be notified by the Central Government in consultation with any financial sector regulator.

(iv) That the order of moratorium shall have effect from 16.08.2017 till the completion of the corporate insolvency resolution process or until this Bench approves the resolution plan under sub-section (1) of Section 31 or passes an order for liquidation of corporate debtor under Section 33, as the case may be.

(v) That the public announcement of the corporate insolvency resolution process shall be made immediately as specified under Section 13 of the Code.

(vi) That this Bench hereby appoints Mr. Velamur Varadan Anand, B 2101, great Eastern Gardens, LBS Marg, Kanjur Marg (West), Mumbai – 400 078 Email ID: [velamur.anand@yahoo.co.in](mailto:velamur.anand@yahoo.co.in), Registration No. IBBI/IPA-002/IP-N00069/2017-18/10147, as Interim Resolution Professional to carry the functions as mentioned under Insolvency & Bankruptcy Code.

9. Accordingly, this Petition is admitted.
