ORDER

Learned counsel for the corporate debtor states that stay has been granted by the Hon'ble NCLAT in Company Appeal (AT) (Insolvency) No. 864 of 2019 vide order dated 17.09.2019 wherein it has been observed that "Until further orders, the 'Interim Resolution Professional' will not make any publication, calling for claims if not published and will not constitute 'Committee of Creditors', if not yet constituted. any settlement.” Learned counsel states that the judgment has been reserved by the Hon’ble Appellate Tribunal.
